- i. If they fail to join their new assignment within 15 days, after the issuance of their posting / adjustment orders, they will be deemed to have forgone their promotion. - iii. Prior to joining of above named promoted officers, DEOs (SE) / Heads of the institutions concerned shall scrutinize the degrees of M.A (relevant subject for Subject Specialists) and B.Ed regarding 2<sup>nd</sup> Division, as required by the relevant promotion rules. In case of some discrepancy / 3<sup>rd</sup> Division in M.A or B.Ed, the promoted officer shall not be allowed to join and report be furnished to this Department immediately, otherwise the joining authorities shall be held responsible.
