- ii) He shall not be posted against any administrative post till the completion of 10 years service as such.
- The District Education Officer (SE)/Head of the institutions concerned shall be responsible to get the academic and professional certificates of the officer/teacher concerned verified, within one month and shall submit certificates in this regard to the DPI(SE), Punjab, under intimation to this department.
