2. The incumbents will not claim transfers before the completion of tenure of three years as prescribed by School Education Department.
3. **Erratic posting will not be admissible in any case. Controlling/joining authority will be responsible for joining against any erratic posting and will be dealt under disciplinary rules.**
4. In case the vacancy where incumbents have been posted is not available / valid, they shall report back the department immediately for further orders.
5. Erratically posted incumbents are relieved of their posts and directed to report to District Coordination Officer, concerned for further adjustment.
