#### **TERMS & CONDITIONS**

1. In case officers fail to join their new assignments within **15 days**, after the issuance of their posting orders, they shall be deemed to have forgone their promotions. The effect of foregoing of promotion entails supersession as clarified in the Regulation Wing S&GFAD instruction bearing No. SOR-II(S&GAD)2-132/2002 dated 03.02.2003, read with SOR-II(S&GAD)2-167/2010, dated 12.11.2010.
2. The incumbents will not claim transfers before the completion of tenure of three years as prescribed by School Education Department.
3. **Erratic posting will not be admissible in any case. Controlling/joining authority will be responsible for joining against any erratic posting and will be dealt under disciplinary rules.**
4. **In case the vacancy where incumbents have been posted is not available / valid, they shall report back the department immediately for further orders.**
5. Erratically posted incumbents are relieved of their posts and directed to report to School Education Department, concerned for further adjustment.
