TERMS & CONDITIONS

- i. If they fail to join their new assignment within 15 days after the issuance of their posting order separately, they will be deemed to have forgone their promotion. The affect of forgoing of promotion entails supersession as clarified in the Regulation Wing, S&GAD's instructions bearing No. SOR-II(S&GAD)2-167/2010 dated 12.11.2010.
- ii. They will not be posted as Headmistress / Assistant Director etc, till the completion of ten years service as such, as per provisions of Recruitment rules (School Education Department) 1987, amended on April 05, 1989 and New Service Rules, 2014.
- iii. The Heads of the Institutions concerned shall be responsible to get the academic and professional certificate of the officer concerned verified, within two months and shall submit certificates in this regard to the DPI (SE), Punjab through proper channel.
- iv. Prior to joining of above promotes, DPI (SE), Punjab, Lahore and Heads of the Institutions shall scrutinize the degrees of M.A (relevant subject) & B. Ed regarding 2nd Division, as required by the relevant

promotion rules and in case of some discrepancy or 3rd Division in M.A or B.Ed, she shall not be allowed to join and report be furnished to the DPI (SE), Punjab under intimation to this Department immediately otherwise they shall be held responsible for the consequences.

- v. They will be relieved from their present places of posting, after issuing of their posting / adjustment orders, separately.
- vi. If any officer has retired / expired prior to the issuance of this Notification, the Notification shall deem to be withdrawn to her extent.
- vii. Their adjustment orders shall be issued after having latest inquiry position.
