- iii. The Heads of the Institutions concerned shall be responsible to get the academic and professional certificate of the officers concerned verified, within two months and shall submit certificates in this regard to the DPI (SE), Punjab through proper channel.
- iv. Prior to joining of above promotees, Heads of the Institutions shall scrutinize the degrees of M. A (relevant subject) & B. Ed regarding 2<sup>nd</sup> Division, as required by the relevant promotion rules and in case of some discrepancy or 3<sup>rd</sup> Division in M. A or B. Ed, they shall not be allowed to join and report be furnished to the DPI (SE), Punjab under intimation to this Department immediately otherwise they shall be held responsible for the consequences.
