S & GAD instruction bearing No. SOR-II (S&GAD) 2 - 132 / 2002, Dated 3-2-2003, read with SOR - II (S & GAD) 2 - 167 / 2010. Dated 12-11-2010.
- ✓ 2- The incumbents will not claim transfers before the completion of tenure prescribed by the School Education Department, Government of the Punjab.
- ✓ 3- Erratic posting will not be admissible in any case. He shall not be posted as Subject Specialist till the completion of 10-Years Service as such.

- 1- In case the vacancy where incumbent has been posted is not available, he shall report back immediately to the DIRECTORATE OF PUBLIC INSTRUCTION (S.E), PUNJAB, for further orders.
