The incumbents who are cleared for promotion to BS-18, their services are hereby placed at the disposal of Section Officer (SE-I) for further posting / adjustment against vacant posts, strictly on merit / seniority, fresh E&D status (Copy Enclosed) and according to placement policy, notified by the Govt. of the Punjab, on the terms and conditions mentioned below:-

TERMS & CONDITIONS:

- i. If they fail to join their new assignment within 15 days after the issuance of their posting order separately, they will be deemed to have forgone her promotion. The affect of forgoing of promotion entails supersession as clarified in the Regulation Wing, S&GAD's instructions bearing No. SOR-II(S&GAD) 2-167/2010 dated November 12, 2010.
- The Heads of the Institutions concerned shall be responsible to get the academic and professional certificate of the officer concerned verified, within two months and shall submit certificates in this regard to the DPI (SE), Punjab through proper channel.
- iii. It is pertinent to mention here that the cases of the officers who have retired from Government service on attaining the age of superannuation of this panel after the date of above mentioned meeting of DPC may be further processed by Section Officer (SE-I) as per provisions of Section 8(7) of the Punjab Civil Servants Act, 1974.
- Prior to joining of above promotees, DPI(SE) Punjab, Lahore and Heads of the Institutions shall scrutinize the degrees of M. A (relevant subject) & B.Ed regarding 2nd Division, as required by the relevant promotion rules and in case of some discrepancy or 3rd Division in M.A or B.Ed, she shall not be allowed to join and report be furnished to the DPI (SE), Punjab under intimation to this Department immediately otherwise she shall be held responsible for the consequences.
- v. They will be relieved from their present places of posting, after issuing of their posting / adjustment orders, separately.
