The effect of foregoing of promotion entails supersession as clarified in the Regulation Wing S&GFAD instruction bearing No. SOR-II(S&GAD)2-132/2002 dated 03.02.2003, read with SOR-II(S&GAD)2-167/2010, dated 12.11.2010.
2. The incumbents will not claim transfers before the completion of tenure of three years as prescribed by School Education Department.
3. Erratic posting will not be admissible in any case. Controlling/joining authority will be responsible for joining against any erratic posting and will be dealt under disciplinary rules.
4. In case the vacancy where incumbents have been posted is not available / valid, they shall report back the department immediately for further orders.
