**ORDER**

**No. SO(SE-I)28-1/2001(P).** Pursuant to the judgment of Supreme Court of Pakistan dated 25.03.2009 in CPLA No.1086-L/2008,1571-L/2008, 1572-L/2008, 1573-L/2008, 1875-L/2008 and order of Lahore High Court, Lahore Bench Lahore dated 19.07.2010 in Writ Petition No.6288/2010, advice of Punjab Public Service Commission, Lahore issued vide letter No. PSC-RD-2010/8398-RD, dated 22.10.2010 and approval of the Chief Minister, Punjab vide summary NO. SO(SE-I)28-12001(P) dated 30-6-2011 the Subject Specialists mentioned below who had been appointed on adhoc basis and their services were extended from time to time and finally terminated on 31<sup>st</sup> December, 1999 are hereby appointed as Subject Specialists on regular basis in their relevant subjects in BS-17 plus usual allowances w.e.f. the date they join duty within prescribed limit of time on the terms and conditions given below. **TERMS AND CONDITIONS:**

1. Regular appointment of incumbents will be subject to fulfillment of requirements of rules 18,19,20,21 and 21-A of the Punjab Civil Servants (Appointment and conditions of services) Rules, 1974.
2. The adhoc appointees on their regular appointment shall remain on probation in terms of section 5 of Punjab Civil Servants Act 1974 and Rule 7 of the Punjab Civil Servants (Appointment and Condition of Service.) Rules, 1974.

3. The service period of adhoc employees prior to regular appointment shall not be counted for any purpose (Pension, Gratuity, Leave, Seniority, Promotion, etc) on their appointment under the Punjab Civil Servant Act, 1974 and the Rules framed there-under.
4. The Seniority of adhoc Subject Specialists shall be reckoned from the date of assumption of charge after their appointment on regular basis and shall be fixed under the relevant provisions of rules.
5. The adhoc Subject Specialists who were proceeded against under E&D Rules or any other Rules / Law and have been removed / dismissed from service or have left the service at their own accord shall not be considered for regular appointment. Director Public Instructions (SE) will verify the facts before issuance of their posting orders.
6. Any Subject Specialist who has not passed B.Ed. Examination or is M.A(English) in III-Division will have to acquire the prescribed qualification / (TEFEL) Training within three years otherwise, the order of regular appointment shall stand cancelled / withdrawn.
7. The respective Heads of Institutions / EDOs (Edu) will get the academic and professional certificates of the Subject Specialists verified from the concerned issuing agencies within one month of their joining.
8. The Subject Specialists shall report immediately to the Director Public Instruction (SE) Punjab, Lahore for getting their posting orders.
